In addition to the **Rules and Regulations** of the Society, the following regulations apply to competitors and entries in the Children’s Section

- Entries will be accepted either from school pupils or individuals.
- **School Entries:** An entry form from each pupil is not required. Only one entry form per school class, in the name of the Teacher, with an attached list of names of pupils submitting work. **Note** that the entry fee applies to each pupil. **Teacher to sign Waiver/Indemnity form.**
- **Exhibits in Section 15 received from schools are to be delivered in BULK. PLEASE USE Bulk Entry Form.** □ Each entry must be marked with pupil’s name, age, class and school on **back of work.**

- **Individual Entries:** are to have a completed entry form & a parent or legal guardian to sign the Waiver/Indemnity form. The Judges’ decision is final. Any disputes must be brought to the Notice of the Chief Steward only during the Show period. An Exhibitor has the right to appeal in writing to the Secretary with a lodgement fee of \$50.00. If the appeal is upheld, the money will be refunded.
- **GROUP A or B**
 - Limit 1 entry per pupil in either group.
 - For display it may be necessary to pin or staple work.
 - **Maximum size - Exhibits to be A4 SIZE ONLY.**
 - **Over-sized work will not be accepted.**
 - **Work that is FRAMED or MOUNTED will not be accepted.**
- **GROUP C**
 - Limit 1 entry per exhibitor.
 - **Maximum size (unframed) 40cm x 50cm (16” x 20”).**
 - **All entries must be ready to hang ie staples and cord or otherwise will not be accepted**

 - 1.1. participation in animal handling is a recreational service for the purposes of section 139A of the Australian Competition and Consumer Act (Cth) 2010 and also a recreational activity for the purposes of section 5K of the Civil Liability Act (NSW) 2002;
 - 1.2. participation in the Event involves a significant risk of physical harm and may result in injury, loss, damage or death to me;
 - 1.3. participation in the Event requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the events;
 - 1.4. If the event is held outdoors, there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or wind;
 - 1.5. I am responsible for ensuring that I have and will wear equipment suitable for safely and properly participating in the Event;
 - 1.6. I am responsible for the condition of any tools and equipment and ensuring that they are appropriate for the Event; and

SCHOOL GROUPS AT ANIMAL HANDLING EVENTS & PARTICIPANT RISK ACKNOWLEDGMENT & WAIVER

Agricultural Societies Council of NSW and the Castle Hill and Hills District Agricultural Society (together **the Suppliers**) advise that participation (including passive participation) in animal handling and competitions at an agricultural show contains elements of risk, both obvious and inherent. The handling of animals is a dangerous recreation activity as animals can act in a sudden and unpredictable way, especially when frightened or hurt.

1. By signing this waiver I acknowledge that:
 - 1.1 participation in animal handling is a recreational service for the purposes of section 139A of the **Australian Competition and Consumer Act (Cth) 2010**, and also a recreational activity for the purposes of section 5K of the **Civil Liability Act (NSW) 2002**;
 - 1.2 Participation in animal handling is a hazardous activity and may result in injury, loss, damage or death to me;
 - 1.3 Participation in animal handling requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the events;
 - 1.4 Animals can act in a sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises;
 - 1.5 Animal showing events will be held in close proximity to rides and large groups of people, and that there may be loud and unfamiliar noises which can frighten animals;
 - 1.6 If the event is held outdoors, there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or wind.
 - 1.7 Insects or other animals may cause animals to become frightened and act in an unpredictable way;
 - 1.8 There is inherent in events involving the handling of animals the risk of suffering injury including injuries caused by animals;
 - 1.9 I use the facilities of the Castle Hill & Hills District Agricultural Society entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me.
2. If I suffer injury, loss or damage ("loss") while participating in the Event, I will not hold the suppliers, their employees or agents legally responsible for any loss I suffer. I will not sue the suppliers, their employees or agents for any claims, costs, damages or liability. I agree to release the suppliers and their employees from legal responsibility for the services I have been provided and/or activity I have participated in.
