Arrival of Exhibits:

- **Personal Delivery:** Exhibits are to be delivered to The Federation Pavilion, Castle Hill Showground on **Sunday 11 March 2012 between 10am to 2pm and Monday 12 March 2012 between 3 pm to 6 pm.**

RECEIPT for payment of entry fees must accompany exhibits on delivery and collection.

- **Exhibits by Mail:** Unbreakable exhibits, accompanied by proof of entry and the cost of return postage, may be posted to arrive **no later than Friday 9th March 2012.**

Return of Exhibits:

- **Personal collection by Individual Entrants:** Exhibits will be available for collection from The Federation Pavilion, Castle Hill Showground **only between the hours of 5pm and 6pm on Sunday 18th March 2012 and between 10am & 4pm on Monday 19th March 2012.**
- **School Exhibits:** Schools to collect their Bulk Exhibits on **Monday 19th March 2012 between 10 am & 4 pm.**
- **Return by Mail:** Exhibits received by mail, with return postage paid, will be returned as soon as possible commencing on Monday 19th March 2012.

NOTE: STUDENTS or young people 17 years and over may enter Section 8 Art

SECTION REGULATIONS

In addition to the Rules and Regulations of the Society, the following regulations apply to competitors and entries in the Children’s Section.

- Entries will be accepted either from school pupils or individuals.
- **School Entries:** An entry form from each pupil is not required. Only one entry form per school class, in the name of the Teacher, with an attached list of names of pupils submitting work. **Note** that the entry fee applies to each pupil. **Teacher to sign Waiver/Indemnity form.**
- **Exhibits in Section 17 received from schools are to be delivered in BULK.**
- Each entry must be marked with pupil’s name, age, class and school on **back of work:**

Example:

Section: 17	Group/Class: B3
Age:	8 - 10 years
Name:	Mary Smith
School & Class	4A Castle Hill Public School
OR Home Address:	address of Individual Entrant

- **Individual Entries:** are to have a completed entry form & a parent or legal guardian to sign the Waiver/Indemnity form.
- The Judges’ decision is final. Any disputes must be brought to the Notice of the Chief Steward only during the Show period. An Exhibitor has the right to appeal in writing to the Secretary with a lodgement fee of \$50.00. If the appeal is upheld, the money will be refunded.
- **GROUP A or B**
 - Limit 1 entry per pupil in either group.
 - For display it may be necessary to pin or staple work.
 - **Maximum size** - Exhibits to be A4 SIZE ONLY.
 - Over-sized work will not be accepted.
 - Work that is FRAMED or MOUNTED will not be accepted.
- **GROUP C**
 - Limit 2 entries per exhibitor.
 - **Works on stretcher canvas unframed size 30cm x 40cm (12" x 16").**

I, the signatory acknowledge the risk referred to above and agree to waive any and all rights the above named minor, or any other person, may have against the Castle Hill Show Society in relation to any loss or injury (including death) that is suffered by the above named minor as a result of participation in this show.
