COLLECTION OF EXHIBITS:

- **Personal collection by Individual Entrants:** Exhibits will be available for collection from The Federation Pavilion, Castle Hill Showground **only between the hours of 5pm and 6pm on Sunday 18th March 2012 and between 10am & 3pm on Monday 19th March 2012.**
- **School Exhibits:** Schools to collect their Bulk Exhibits on **Monday 19th March 2012 - 10.00 am to 3.00 pm.**
- **Return by Mail:** Exhibits received by mail, with return postage paid, will be returned as soon as possible commencing on Tuesday **20th March 2012.**

RECEIPT for payment of entry fees will be required when collecting exhibits.

PLEASE NOTE: Exhibitors are reminded that it is their responsibility to arrange insurance cover for exhibits while in transit (both ways) and while at the Show.

WAIVER/INDEMNITY FORM

Each Exhibitor named on the entry form must sign the Waiver/Indemnity form following and attach to the entry form.

PHOTOGRAPHY SECTION REGULATIONS

In addition to the Rules and Regulations of the Society, the following regulations apply to competitors and entries in the Photography Section.

- All entries must be the work of the Exhibitor but not necessarily processed by the Exhibitor.
- The work not to be larger than 41cm x 51 cm including Matt Mount.
- All prints are to be mounted on Matt Board. No glass and/or framed prints accepted.
- All Exhibitors must be amateurs.
- Exhibitors in the Junior section must be under 16 years old.
- All exhibits must have been taken within 18 months prior to the Show.
- Images must have a photographic origin and entrants must hold the copyright for the images.
- An image which received an award in last year's exhibition may not be entered in the same or a different section of this year's exhibition.
- A maximum of **FOUR IMAGES** may be submitted in each section No Image shall be entered in more than one section of the exhibition.
- All exhibits **MUST** be labelled on the back of the photo with the following details:
 - Arrow indication of top of photo;
 - Group and Section;
 - Name of Photographer
 - School Name, if applicable;
 - Blank line;
 - Title of Photos.

DEFINITIONS:

- **Monochrome** Any photograph containing shades of only one colour. If toning is carried out, it must be over the total photograph - partial toning and/or the addition of one extra colour is not acceptable as a monochrome section.
- **Open Section** Any subject that is treated pictorially, embodying the elements of good design, arrangement or composition, which reflects the personal interpretation of the photographer.
- **Nature photography** depicts living, untamed animals and uncultivated plants in a natural habitat, geology and the wide diversity of natural phenomena, from insects to icebergs. Photographs of animals that are domesticated, caged or under any form of restraint, as well as photographs of cultivated plants are ineligible – **except in the Junior Sections.**
- **Creative** covers photographs that display a novel effect because of an unusual combination of objects and /or viewpoint. They are images that have been modified during or after exposure. The image must have a photographic base with the original work being exposed by the entrant.

PARTICIPANT'S INDEMNITY & WAIVER

RISK WARNING
