There will be a limit to class sizes and priority will be taken for entries received early.

LATE ENTRIES will NOT be accepted either after the closing date or on the day but changes may be made during the Show.

REGISTRATION

All Horses and Riders must be current registered Showjumpers with the E.F.A. (Except for Unofficial classes on Sunday). Junior Equitation riders must be members of EFA. Current registration cards must be produced when entering.
